This warranty is only applicable to MAVERICK™ GARAGEWORX CABINETRY products used in residential applications within the United States and is nontransferable to subsequent end-users or owners. This warranty does not apply to damages from improper handling, alterations, misuse, installation, or product used for any other purpose than normal use. Should defects in material exist or occur during the warranty period Innovation Cabinetry, LLC. will elect, at its sole discretion, to either (1) repair or replace the defective component free of charge to the end-user or (2) refund the purchase price of the defective component.

This warranty covers only materials and components of MAVERICK™ GARAGEWORX CABINETRY products supplied by Innovation Cabinetry, LLC. shall not be responsible for any consequential damages, lost profits, or any other costs or damages, all of which are expressly excluded, including without limitation labor, installation, shipping, transport, disposal, or any costs associated with the product, including, without limitation, plumbing, walls, flooring, fixtures, gas or electric appliances, or countertops, all expressly excluded.

This warranty shall become void if the cabinets are in any way modified, improperly installed, or damaged before or during the installation process. Upon completing the assembly or installation process, the cabinetry will be deemed accepted by the purchaser.

We cannot accept any requests for exchanges or returns for items assembled or installed. This warranty shall become void if used in any application other than the standard uses for residential cabinetry. Furthermore, this warranty will not apply to cabinets damaged by misuse, neglect, abuse, acts of God, exposure to moisture, exposure to extreme temperatures, superficial cracks in paint at the wood joints caused by the natural expansion and contraction of components, or the effects of normal wear and tear.

Cabinetry will vary in color and characteristics and exhibit subtle changes as they age. Sunlight, smoke, household cleaners, and other environmental conditions may also affect the color match over time. These variations are considered the nature of the materials in relation to their environment and exposures and are not covered under this warranty.

If a warranty claim is filed after an MAVERICK™ GARAGEWORX CABINETRY product becomes obsolete, Innovation Cabinetry, LLC. reserves the right to honor the warranty in one of the following fashions:

- To replace the affected component with a new component of the same style.
- To replace the affected component and any other component(s) in the residential application to achieve a reasonably uniform appearance with a similar and comparable MAVERICK™ GARAGEWORX CABINETRY product style of the originally purchased style.
- To refund the purchase price of the defective component. If cabinetry components are replaced, Innovation Cabinetry, LLC. cannot guarantee that the finish of these replacements will exactly match the finish and appearance of the components in the existing residential application. This is due to natural variations and changes during the cabinet's natural aging process, affecting its color.
